#### LOCATION

Elwick Place is a 100,000 sq.ft. leisure, cinema and restaurant complex located in the heart of Ashford town centre where Elwick Road meets Bank Street in the 'shared space' area. Despite being a new complex within the Town Centre, it is proving to be a very popular leisure destination offering a variety of food and beverage destinations complimented by Picturehouse cinema, Travelodge Hotel, Snap Fitness (gym) and The Snug (home and lifestyle store).

Ashford, one of Kent's designated growth centres, currently has a population of approximately 75,000 inhabitants and is set to grow substantially in the next 20 years. The town is centrally located within the county, benefitting from a fine communications network via the A20/M20 and five mainline railways. Ashford International Passenger station gives direct access to northern continental Europe via Eurostar and London is some 38 minutes distant via HS-1.

#### DESCRIPTION

These two retail units are very prominently located next to the Elwick Place car park and are also visible from the shared space road system on Elwick Road. Located on the ground floor of the Elwick Place development, providing just over 8,500 sq. ft. of retail space, these two units are open plan and were previously operated as a food hall/restaurant and farm shop. There is a large glass and aluminium shop front containing double doors 8'8" wide facing on to the pedestrianised area and across to County Square along with a glazed return frontage onto the car park. There are WC facilities at the rear of the unit and a rear pedestrian access door. Externally, there is the option for outside customer seating, subject to landlord's consent and a car park shared for all tenants/customers on a pay and display basis.
